**RESOLUTION OF THE RE-ELECT DAVID COHEN COMMITTEE**

WHEREAS, the Re-elect David Cohen Committee (sometimes herein the "Committee") is a political committee created under the Election Code of the Commonwealth of Pennsylvania by the filing twenty-seven ago with the City Commissioners, constituting the Board of Elections of the City and County of Philadelphia, of a Political Committee Registration Statement designating a chairman and treasurer of the Committee; and

WHEREAS, the original Political Committee Registration Statement filed with the Board of Elections can no longer be located; and

WHEREAS, for approximately twenty-five years John J. French has been the Treasurer of the Committee; and

WHEREAS, during the entire existence of the Committee, until his death in late 2005, the Chairman of the Committee was the Honorable David Cohen, Member at Large of City Council; and


WHEREAS, under Section 1622 of the Pennsylvania Election Code, 25 P.S. § 3242, every political committee is required to have a treasurer and a chairman and a political committee may not transfer funds while there is a vacancy in either one of those offices; and

WHEREAS, John J. French, in his capacity as the sole surviving officer and member of the Committee, has consulted with legal counsel, Gregory M. Harvey of Montgomery, McCracken, Walker & Rhoads, LLP, and has consulted with Florence Cohen, widow of David Cohen, concerning the designation of a new Chairman of the Committee in order that the Committee may transfer funds; and

WHEREAS, John J. French is satisfied that the designation of Sherrie Cohen, Esquire, daughter of David Cohen, as Chairman of the Committee would be consistent with the wishes of the late David Cohen and is consistent with the wishes of his widow, Florence Cohen;

NOW THEREFORE, be it RESOLVED by the Re-elect David Cohen Committee, that Sherrie Cohen, Esquire, is designated as Chair of the Committee, filling the vacancy created by the death of David Cohen, and that an Amended Political Committee Registration Statement showing the officers of the Committee as Sherrie Cohen, Esquire, Chairman, and John J. French, Treasurer, be executed and filed with the City Commissioners constituting the Board of Elections of the City and County of Philadelphia.
